## BOARD HIGHLIGHTS - APRIL 17, 2017 MEETING, 7:00 PM

**CONSENT AGENDA** – The consent agenda was approved as presented.

### **DISCUSSION ITEMS**

<u>Curriculum Report (SP Goal: Student Achievement, Resources)</u>. A Technology update report was provided on the new website, professional development and device renewal. Matt Hanley overviewed the website and timeline for the June launch. Jeff Romani then explained how the District is using Google Classroom and how professional development training on the G-Suite is provided in-district so it can be customized and tailored to our needs. He reviewed forthcoming priorities including staff and lab hardware upgrades, an increase in data and user security measures plus improvement to connectivity.

<u>Special Education Transportation Bid (SP Goal: Resources)</u>. Asst. Supt. Jones presented the bid results received for in-district special education transportation. Four of the CASE districts bid together with language allowing for separation without impact to the negotiated price should one district decide to terminate their individual contract. Even though Hopewell Services' bid was 51.5% higher than prices we currently pay with Septran, they were the lowest bidder. She noted that 80% of this increase will be bore by the State through the reimbursement process, unless the formula changes in the near future.

<u>Board Planning for the May 1, 2017 Organizational Meeting</u>. Supt. Tammaru reviewed the agenda for the May 1<sup>st</sup> Organizational meeting. Certified results from the April 4, 2017 School Board election will be approved and new Board Members Jay Lerch and La Sridhar will take the oath of office.

<u>2017-2018 Board Meeting Dates</u>. Supt. Tammaru presented a draft of the proposed 2017-2018 Board of Education meeting dates for discussion.
