BOARD HIGHLIGHTS - AUGUST 15, 2016 MEETING, 7:00 PM

CONSENT AGENDA – The consent agenda was approved as presented.

DISCUSSION ITEMS

<u>2016-2017 Tentative Budget (SP Goal: Resources)</u>. Asst. Supt. Jones provided a summary of the 2016-2017 tentative budget and reviewed major changes to the budget from the prior presented projection. The 2016-2017 budget reflects a \$566,243 deficit in the Operating Funds, an increase of approximately \$190K from the previous projection model. She addressed revenue and expenditure assumptions along with providing history of revenue, expenditures and fund balances. She included an update on the State budget crisis reporting significant talk continues on pushing the normal cost of TRS pensions to local school districts, a two-year property tax freeze and proration of regular education transportation.

<u>Post-Accrual Variances Analysis (SP Goal: Resources)</u>. Asst. Supt. Jones provided a preliminary review and explanation of the estimated 2015-2016 end-of year budget to actual variances. This report reflects the differences between our cash balances and accrued balances as of June 30th. Although unaudited, it appears the district will end the year with a surplus of roughly \$337K versus the budgeted surplus of \$317K.

<u>Board Self-Evaluation Report</u>. Supt. Tammaru reviewed the changes made to the Board Agreements and Board/Superintendent Communications expectations following the July 11th IASB workshop with Field Director Barb Toney. The Board felt the report captured the night's conversation accurately.
