## BOARD HIGHLIGHTS - SEPTEMBER 24, 2018 MEETING, 7:06PM

**<u>CONSENT AGENDA</u>** – The consent agenda was approved as presented.

## **DISCUSSION ITEMS**

<u>Financial Planning (SP Goal: Resources)</u>. Assistant Superintendent Jones overviewed the 2018-2019 final budget. There are no changes to the final budget from the tentative budget presented in August. The district anticipates approximately a \$1.4M deficit for the 2018-2019 fiscal year leaving a \$200K fund balance less early taxes. The targeted 10% fund balance will fall below 1% at the end of the 2018-2019 school year and, if there are no changes to our revenue, the district will be borrowing money from themselves in May 2019.

Student Achievement Reports (SP Goal: Student Achievement). A summary report of preliminary student achievement data from 2017-2018 was reviewed. All work is aligned to the Strategic Plan, and all School Improvement Plans are based off the Strategic Plan and Critical Action Steps. Assistant Superintendent Langman and Superintendent Tammaru provided the report based on summative MAP achievement and growth data as well as summative PARCC achievement data. PARCC growth data has not been finalized and the district is still waiting on growth reports for final designations. Dr. Langman highlighted successes and areas for growth. The District continues to perform well above the national average by one to two grade levels on MAP, however, there are significant learning gaps between our subgroups. PARCC data is discrepant from MAP data, however, PARCC is how the District is measured on a state level.
