Measure of Academic Progress (MAP) testing data results show academic achievement. While overall growth is not being met on our national benchmarks, D89 continues to expect and achieve awesome results in growth. We have received feedback from our first-ever Behavioral and Emotional Screening System (BESS). We see a fuller picture of the CCSD 89 student body. As a group, D89 students feel secure in their social-emotional health. CCSD 89 continues to support our children academically, emotionally and socially.
