**BOARD HIGHLIGHTS – FEBRUARY 27, 2023 MEETING - 7:00 PM**

**CONSENT AGENDA** – The consent agenda was approved as presented.

**DISCUSSION ITEMS**

**Financial Projections** (*BOE Goals: Changing financial needs and collaborative and inclusive culture*). Assistant Superintendent for Finance Maureen Jones provided the Board with an updated five-year projection. The funds from the last district referendum have been maintained and used productively.

**Final staffing recommendations for the 2023-24 school year** (*BOE Goal: Continuous improvement and changing financial needs*) Superintendent Tammaru and the Board Members came to a consensus about the addition of 2 school psychologists at the elementary level for all five schools for the 2023-24 school year to help best meet the needs of students, staff, and families.

The overall estimated net change in expenditure for the staffing changes is \$398,170.
