#### **DISCUSSION ITEMS**

- <u>Future Calendar Feedback</u> (*BOE Goals: Collaborative and inclusive culture*). Hundreds of staff and family members provided feedback, ideas and suggestions for future calendar modifications. These suggestions will be considered for the 2025-26 school year calendar (and beyond). There is significant support for the district to apply for an eLearning Program certificate. Several staff members support modifying special's schedules to accommodate Monday classes. Recommendations and suggestions will be brought to district leadership teams to discuss possible implementation.
- Staffing 2024-2025 with enrollment (BOE Goals: Continuous improvement and improved student learning). A variety of data is reviewed to access the number of hired staff that would be needed for a school year. To name a few: enrollment, special education minutes, English language learners, students receiving intervention, students receiving challenge support, special education referrals, and instructional assistant support, etc..., are all taken into consideration. Staff change recommendations would be based on the data that has been reviewed.
