BOARD HIGHLIGHTS – JUNE 17, 2024 MEETING - 7:00PM

CONSENT AGENDA – The consent agenda was approved as presented.

DISCUSSION ITEMS

- **Northwestern University Center for Talent Development Gifted/Advanced Program Evaluation Presentation** (*BOE Goal: Continuous improvement*). Dr. Susan Corwith presented the gifted/advanced program evaluation process and recommendations for consideration. Dr. Corwith recommended that D89 come to a consensus about the approach to the gifted/advanced services that would be offered and effectively communicate this information to stakeholders, expand the continuum of services focusing on the rigor of Tier 1 instruction, revisit the identification process and acceleration criteria and create an onboarding procedure for new administrators and educators and provide professional learning opportunities for all staff.
- **Significant Disproportionality Update** (*BOE Goal: Continuous improvement, improved student learning and collaborative and inclusive culture*). Student services director, Katie Kreller, provided an update on the work being done to address the significant disproportionality finding within our special education identification. In 2021, CCSD 89 was notified by the Illinois State Board of Education that the district was overidentifying Black children with specific learning disabilities. The current plan has the overall goals to develop and implement a transfer mentoring program for new students and families, specifically targeting transfer students with disabilities and students who qualify for free and reduced lunch, to retrained staff on screening, eligibility and indicators of Specific Learning Disability and develops an ongoing coaching cycle for staff to ensure equitable opportunities for every student.
- **Annual Policy review** (*BOE Goal: Continuous improvement*).
