DISCUSSION ITEMS

<u>Strategic Plan -</u> Superintendent Tammaru presented the focus areas as defined by the stakeholder feedback. Superintendent Tammaru reviewed the district's Strategic Plan's five goals and the progress that has been made this year towards those goals. All work is aligned to the district's Strategic Plan. She highlighted successes and opportunities for growth for every single student in academic success, social-emotional development, high-quality staff, community interactive engagement and effective use of resources.
