Consent Agenda – The consent agenda was approved as presented.

DISCUSSION ITEMS

Employee Health and Dental Insurance Renewal (BOE Goal: Changing Financial Needs)

The Board reviewed employee health and dental insurance renewal options. The rates are determined by the EBC, Educational Benefit Cooperative for medical and dental insurance coverage. The cooperative is self-funded for the PPO and dental plans, and fully insured for the HMO plan. The cooperative increases premiums annually in anticipation of the increase in medical expenditures and insurables in the pool. The rates given are based on claims as a whole and include the average claim for all EBC districts in the state and compares to the average claim within District 89. For the 2021-22 contract year, PPO decreased 1.1%, HMO decreased 3.9%, and Dental decreased 4.1%. Additionally, the EBC executive board elected to refund \$5M in accumulated fund balance this year as a result of the financial audit and the actuary study on expected future claims.

Strategic Plan Update

Superintendent Tammaru shared the corresponding goals that were voiced during the AM and PM sessions of the strategic plan meetings. Statements were made that clearly define and prioritize the organization's expectations. Goals were bold and realistic and statements set a general direction with enough specificity to be helpful. The groups focused on objectives, strategies, immediate actions and steps, specific measurable and attainable goals and quantifiable milestones. Stakeholders want to ensure that our learning community treats one another respectfully and works collaboratively to achieve our mission and vision.
