DISCUSSION ITEMS

2021-2022 Board Meeting Dates

Supt. Tammaru presented a draft of the 2021-2022 Board of Education meeting dates. She reported meetings are typically held on the third Monday of the month. The Board of Education reviewed and discussed the meeting dates for the 2021-2022 school year.

Strategic planning

Jeffery Cohn from Brave Dialogue provided an update on the D89 strategic plan. Mr. Cohn reviewed the mission, visions and values of CCSD 89 and then discussed the process by which the district will begin the process of updating the strategic plan goals and action plans. The presentation summarized the work the Board of Education will need to complete. They will review the current values/beliefs, mission and vision statements and establish a goal for the process; as well as define the scope of the planning process.

SUPERINTENDENT'S REPORT - Supt. Tammaru's report included information regarding the following:

- Learning in a pandemic – Update and MAP review
Supt. Tammaru's shared information regarding the decline in infection rates, the opportunity that all staff members have to be vaccinated, if they choose, about 500 students will continue to learn remotely this year, student have continued to make academic progress, in-person and remote learners show similar levels of achievement and teachers will use data to meet the needs of each student through the end of the year. Even during a pandemic, families have had the opportunity to learn in the environment that best meets their health needs.
- April 6 election day
Because Glen Crest Middle School is a polling place, the middle school will shift a remote learning day from Wednesday, April 7, to Tuesday, April 6, for that week only. Glen crest students will attend remotely on Tuesday, April 6. All students will attend live classes on Wednesday, April 7. Elementary school schedules will not be effected.
