

Glen Crest families:

This letter is to inform you that two students who were at Glen Crest Middle School tested positive for COVID-19. Due to privacy restrictions, we will not share the students' names. One student was last in the building on Thursday, September 2; the second student was last in the building on Friday, September 3. The district received notification of both positive cases on Wednesday, September 8.

The district reviews all cases with the health department for signs of spread or outbreak within a school. Families would be notified if the health department recommended any attendance change for all or part of the school.

The district is working directly with the DuPage County Health Department to identify any students or staff who were a close contact, which is defined as anyone who spent 15 cumulative minutes within three feet of the infected person during the 24 hours prior to the student showing symptoms. **If your student was a close contact, you will receive a phone call followed by a letter with specific instructions for next steps. If you are not contacted, your student was not a close contact.**

Students and staff at Glen Crest Middle School were following, and continue to follow, protocols for social distancing, hand washing, air ventilation, monitoring, and universal masking. The district will continue to follow all cleaning recommendations from the Centers for Disease Control, state health officials, and local health departments.

Parents should take their child's temperature each day and keep them home if their temperature is 100.4 or greater or they have [COVID-19 symptoms](#). Students should stay home and contact the school nurse if they are positive for COVID-19, have COVID-19 symptoms, or have been in contact with someone who is positive for COVID-19. Families can use this chart (<https://bit.ly/3jyrv3y>) as a starting point when determining whether your student needs to be quarantined or isolated. School nurses or your family's doctor can help resolve any questions.

There is no immediate action you need to take. At this time, the most important things you can do are:

- Make sure your child wears a mask covering their nose and mouth at school.
- Make sure your child washes their hands regularly.
- Encourage your student to maintain social distancing.
- Reduce your exposure and risk outside of school.
- Stay home if you are sick or, if in the previous 14 days, you have had contact with someone with a confirmed diagnosis of COVID-19, is under investigation for COVID-19, or is ill with a respiratory illness. Call your primary healthcare provider if you or a household member has symptoms of COVID-19.

The district will continue to enforce safe practices to prevent, promptly identify, and respond to potential COVID-19 cases. Detailed information about COVID-19 symptoms can be found at the Illinois Department of Public Health's website: www.dph.illinois.gov
