**BOARD HIGHLIGHTS - OCTOBER 21, 2024 MEETING - 7:00PM**

**PRESENT:** Members Koger, Kemp, Pope, Neurauter, Núñez, McGee, Lerch

**CONSENT AGENDA** – The consent agenda was approved as presented.

**DISCUSSION ITEMS**

- **Report on Buildings' School Improvement Plans** (*BOE Goals: Changing financial needs and collaborative and inclusive culture*). An overview of buildings' school improvement plans was presented. Each principal highlighted one aspect of their school improvement plan. Arbor View Elementary School - Principal Dawn McCray's teachers focus on student growth and will routinely reorganize small groups of students. These students will receive additional targeted support and/or challenge their needs in reading skills. Briar Glen Elementary School - Principal Mitch Dubinsky's goal is also student growth. The students at Briar Glen will work with their teachers to set measurable, short-term math and reading goals that contribute to the classroom's larger academic goal. Glen Crest Middle School - Assistant Principal Sammy Smith shared that the Glen Crest staff will continue to use questioning classroom discussion strategies to garner deeper responses and help students feel more invested in the learning process. Park View Elementary School - Principal Kristie Mate highlighted the student growth process at Park View. Teachers are partnering with after-school tutors to target specific math and reading skills that students need additional support to master. Westfield Elementary School - Principal Kristen Ulery underscored that Westfield's teachers are systematically using small group instruction that is focused on word work and foundational reading skills that need further development or acceleration for each student.
- **IASB Delegate Assembly Resolutions** (*BOE Goals: Continuous improvement and changing financial needs*). The Board reviewed the 2024 Resolutions Committee Report. The Board discussed the recommended resolutions that the IASB's Delegate committee will be acting upon during the annual meeting on November 23, 2024. The Board prepared Member Neurauter how to vote and offer questions on behalf of the Board.
- **Enrollment/Registration discussion** (*BOE Goal: Continuous improvement*). In preparation for registration for the 2025-2026 school year, Superintendent Eccarius and the Board of Education discussed current practices and ways to potentially adjust current procedures.
